Agenda Item No. 01: Welcome note by Chairperson.

Agenda Item No. 02: Overview & design of the academic program(s)- Presentation and discussion on the current academic programs offered.

Discussion: It was suggested by the members that for assessment purposes practical/ field based work should be given to the students. They also suggested some places like NGT, DLSA, Jail (Research work on schemes offered by the authorities for project funding) for students to visit as part of academic excursion. Based on such experiences assessment/ assignment work should be outlined. Apart from this the overall design of the academic program for BA LL.B & LL.B was approved.

(Resolution No.: AC/2024/03/02): "RESOLVED THAT, Assessment and Assignment should be given which outline them in a practical field. Every Semester field Visits will be there like Legislative Assembly Visit, Jail Visit etc. as annexed in Annexure_A

Agenda Item No. 03: Assessment and evaluation scheme for program(s) - To define Evaluation and Assessment schemes.

Discussion: The proposed evaluation and assessment structure for all B.A LL.B, & LL.B was deliberated upon. It was proposed to revise the credit scheme for core law subjects, increasing the credits from 3 to 4 for each subject. It was unanimously decided to implement a blended assessment scheme balancing theoretical and practical aspects subject to the nature of the law subjects.

(Resolution No.: AC/2024/03/03): "RESOLVED THAT, The Credits for the Core Subjects has been increased to 4 Credits and blended assessment scheme balancing theoretical and practical aspects subject to the nature of the law subjects. MOOC's Courses should be taken as part of Assessment or Assignment not as a Core Subjects. as annexed in Annexure_B

Agenda Item No. 04: Ratification, Recommendations and approval -To recommend and approve the program Structure for B.A. LL. B and LL. B. Course as per the virtue of the University.

Discussion: The proposed program structures for the B.A. LL.B. and LL.B. courses were reviewed in detail. The members recommended limiting the Number of subjects per semester to a maximum of six. Recommendations for increasing the Number of elective subjects. It was also suggested to include the reading of books as part of the General English subject for the first year of the B.A. LL.B. and LL.B. programs.

Agenda Item No. 05: Any other points with the permission of the chair.

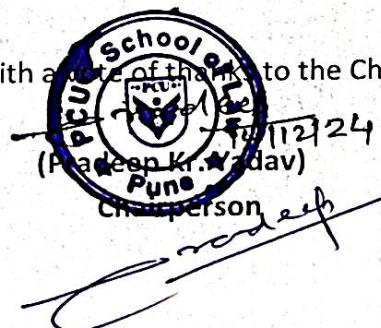
