Agenda Item No. 01: Welcome note by the Chairperson.

Agenda Item No. 02: To consider and approve the change in the Evaluation Scheme of Internal Marks of B.A.LL.B. and LL.B.

Discussion: The members deliberated upon the existing evaluation scheme for internal assessment. It was suggested that instead of considering the best of two Continuous Internal Assessments (CIAs), the evaluation should be based on the average of the two CIAs to ensure consistency and fairness.

The proposal was unanimously agreed upon by all members.

(Resolution No.: BOS/2025/03/01): "RESOLVED THAT, the recommendation that the evaluation scheme for internal assessment of B.A.LL.B. and LL.B. programmes shall be based on the average of the two CIAs shall be forwarded to higher authorities for decision, as annexed in **Annexure A&B"**

Agenda Item No. 03: To recommend and approve the Programme Structure of BA LL.B. and LL.B. - Semester IV- Presentation of IV Semester Proposed Syllabus

Discussion: The proposed Semester IV syllabus for B.A.LL.B. and LL.B. programmes was placed before the Board. After detailed deliberations, the following suggestions were made:

- The credit structure of the Alternate Dispute Resolution course in LL.B. should be revised from 2 theory credits and 1 practical credit to 3 theory credits.
- The Labour Law-I course should be updated to include the new Labour Codes.
- Court Room Exercise-II should include mandatory visits to Lok Adalats as part of experiential learning.
- The syllabus of Law of Contract II in B.A.LL.B and LL.B. and Law of Evidence in LL.B should be updated.

(Resolution No.: BOS/2025/03/02): "RESOLVED THAT, the credit distribution of the Alternate Dispute Resolution course shall be revised to 3 theory credits, and the other suggested syllabus modifications are approved, as annexed in Annexure- C.

Agenda Item No. 04: To review the existing Programme Structure of BA LL.B., LL.B. & LL.M. programmes.

Discussion: The existing programme structures of B.A.LL.B., LL.B., and LL.M. were reviewed in detail. The members suggested that in the B.A.LL.B. programme, Psychology and Journalism and Mass Media courses be replaced with Political Science and Sociology from next academic batch (2026 onwards), as these subjects have stronger relevance to legal studies.

(Resolution No.: BOS/2025/03/03): “**RESOLVED THAT** the proposed changes in the B.A.LL.B. programme structure, including replacement of Psychology and Journalism with Political Science and Sociology, are noted and shall be forwarded to the Higher Authorities for decision.”

Agenda Item No. 05: Any other points with the permission of the chair.

Discussion: The members suggested that teaching assignments for the LL.M. programmes should include case studies to enhance analytical and practical learning. It was further recommended that the case study method be expressly incorporated as a pedagogical approach in teaching and learning processes, wherever appropriate.

(Resolution No.: BOS/2025/03/04): “**RESOLVED THAT**, we will be abiding all the recommendations”
